Setting the process and procedures for accrediting

## **SUMMARY**

Kosovo adopted an administrative instruction on Recognition of Prior Learning (RPL) in 2014. The National Qualification Authority (NQA) has been leading the implementation of RPL, starting with designing of a methodology, executing a training course for RPL assessors, mentors and coordinators, and exposing potential RPL practitioners to EU good practices in Member-States. In 2017, NQA completed a RPL pilot of two occupations/qualifications with four providers. Based on the results of the pilot, NQA has revised the RPL policy and procedures document, which the NQA Board has adopted in January 2018. NQA is now focusing on the definition and application of the procedures for RPL providers' accreditation. The process of accreditation needs to be regulated by an Administrative Instruction to be adopted by the Ministry of Education and Sports, in 2018. The EU funded ALLED II project, scheduled to start by Q3 2018, will include further capacity building activities on RPL.

In March 2018, ETF organised a joint Kosovo-Albania-Former Yugoslav Republic of Macedonia workshop based on a peer learning format, aiming to improve capacities of country teams in VNFIL design and implementation. It was a technical workshop with concrete outputs: (a) two drafted first versions of by-laws, respectively, for Albania and for the Former Yugoslav Republic of Macedonia; and (b) draft procedures and processes for the accreditation of RPL providers, by country. Further to this joint workshop, the NQA has organised a follow-up meeting at the end of April 2018, in Kosovo, for revising the first set of ideas discussed and formulated in Tirana.

This workshop aims at consolidating the defined accreditation process workflow and to draft the necessary forms and other supporting documents for the submission of the accreditation process by the potential RPL providers, in order to have a final draft of the Administrative Instruction that will support the entire process.
