





# **ETF Entrepreneurship Award**

## Why an ETF Entrepreneurship Award?

How entrepreneurship is promoted through vocational education and training is acquiring increasing policy attention in the European Union set against efforts to build more competitive and employable economies. Entrepreneurship as a key competence, essential to building entrepreneurial mindsets and character of young people in particular, is the latest area of policy development. Through its work, the European Training Foundation (ETF) also encourages its partner countries to consider developing entrepreneurship key competence within vocational education and training; as well as to share their good practice.

Given that the entrepreneurship key competence area is still developing, access to good practice provides teachers, curriculum specialists, training providers, as well as policymakers, with ideas and opportunities to develop their own work (see EntreComp Into Action:

https://ec.europa.eu/jrc/en/publication/eur-scientific-and-technical-research-reports/entrecompaction-get-inspired-make-it-happen-user-guide-european-entrepreneurship-competence). To this end, ETF is launching a call to identify good practice in entrepreneurship key competence development.

## What is EntreComp?

EntreComp, the European Entrepreneurship Competence Framework, is made up of three competence areas: a) Ideas & Opportunities, b) Resources, and c) Into Action. Each of the areas comprises five competences that together constitute the building blocks of entrepreneurship as a competence. The framework develops the 15 competences along an 8-level life-long learning model. It also includes examples of learning outcomes for the competence areas. EntreComp can be used as a basis for the development of curricula and learning outcomes, as well as teaching and learning plans. # **Selection process**

An ETF selection committee, consisting of ETF staff and an external expert representing an ETF Entrepreneurship Award winning training provider, will review all submissions against two criteria: (1) learning outcomes for the EntreComp competence areas and (2) the teaching and learning approaches used in the practice.

Two training providers will be pre-selected by the selection committee and nominated to take part in an online public voting about one month before the EU Vocational Skills Week (EVSW) 2019. This public voting is organised by the European Commission via the website of the EVSW, where the two nominees for the ETF award and their practices as well as other nominees for other awards organised by other EU institutions/agencies will be presented to the wider public. The public voting process will last about one month and will be accompanied by a communication campaign.

During the EVSW, each nominee will be called on stage to talk about their practice and work they do related to the award call they applied for. All participants who registered and are present at the event venue can vote for their preferred candidate. After that, the European Commission identifies the winners per award category, including the winner of the ETF award based on the following logic:

Step 1: pre-selection by the ETF selection committee. Weight 40%

Step 2: public online voting on the EVSW website. Weight 40%

Step 3: voting via EVSW App during the dedicated event of the EVSW. Weight 20%

The winner will be announced during the EVSW 2019 as well as on the EVSW and ETF websites and social media channels and will receive an award by the EU Commissioner for Employment, Social Affairs, Skills and Labour Mobility. Please see privacy statement (annex).

#### **Award ceremony**

A representative of each of the two nominated training organisations pre-selected for the ETF Entrepreneurship Award, and a related education and training policy maker for each of the two nominees, who is associated with the training provision, will be invited to Helsinki, Finland, to participate in an award ceremony to celebrate the 2019 European Vocational Skills Week (see <a href="https://ec.europa.eu/social/vocational-skills-week/evsw2018">https://ec.europa.eu/social/vocational-skills-week/evsw2018</a> en). The ETF Entrepreneurship Award will be conferred by the European Commissioner for Employment, Social Affairs and Inclusion at a dedicated award event during the EVSW.
