In the framework of the Comprehensive and Enhanced Partnership Agreement (CEPA), the Five Year Government Programme and the Education development strategy for Armenia, the **EU-Armenia policy dialogue on education** aims to **outline the main directions and objectives**, and draw up a **roadmap for the implementation** of the **Reform Agenda of Armenia in the Education sector**.

This will be supported by the Torino Process which tracks developments in vocational education and training in partner countries of the European Union (EU). A core principle of the Torino Process is ownership and participation of all key stakeholders in the participating countries, including social partners and civil society. The Torino Process enables partner countries to monitor the implementation of Vocational Education and Training (VET) reforms, assess progress and impact on citizens and agree about future priorities.

The objectives of this first meeting include:

- To launch initial discussions on the main objectives of the education sector reform in Armenia and the possible EU support for this process;
- To introduce the Torino Process 2018-20 objectives and strategic orientations, in particular in the context of Armenia;
- To discuss added value of Torino Process in the framework of the EU-Armenia policy dialogue on education;
- To present the ETF assessment of the Human capital development in Armenia;
- To agree on the next steps and timeframe.
