OBJECTIVE

The Torino Process (TRP) is an evidence-informed analysis of Human Capital Development issues and VET policies responses in the ETF partner countries. The process, launched by the ETF for the first time in 2010, enters in its fifth round of implementation that will be completed in the period 2019-2020. Egypt participated in the Torino process since 2010
