SUMMARY


The Torino Process is an evidence based analysis of Human Capital Development (HCD) issues and VET policy responses in the ETF partner countries. The process, launched by the ETF for the first time in 2010, enters in its fifth round of implementation that will be completed in the period 2019-2020.

This online workshop is part of the dissemination phase of the Torino Process fifth round. It has the primary objective to discuss findings and policy recommendations resulting from the process, its outputs and deliverables.

Specific objectives of the workshop are the following:

- share with participants the key findings of the national report and the ETF HCD assessment in Jordan;

- identify possible actions to address the recommendations, in line with current and planned reforms in education and training.
