Purpose of the processing

Legal basis

Personal data

Personal data concerned are:

- Name and contact details (address, Email, telephone) of the person representing the participating school, education provider, teacher, learner, public body, individual, policy maker.
- The data is provided in the application form.

Recipients of the personal data

For the purpose detailed above, access to personal data is provided to the following processing entities:

For all applicants:

- The ETF team managing the call and one external reviewer administering the call on a need-to-know basis
- All members of the ETF good practice team

For the selected nominees:

- All public that access ETF website, digital platforms and social media channels
- Partner organisations participating in the call (European Commission, CEDEFOP, UNESCO, UN Agencies)

For the final ETF award winner(s):

- All public that receives a copy of the good practice information note/publication
- All public that access ETF website, digital platforms and social media channels
- All public that access websites/social media of the partner organisations

The ETF will not divulge personal data for direct marketing or commercial purposes.

Data retention

Data collected will be retained for 2 years following the completion of the call and the publication of the good practice on the ETF Good Practice Platform.
