BACKGROUND

Career guidance and career learning for youth play a fundamental role in shaping the long-term prospects of individuals and communities. It extends beyond merely charting a path to employment and serves as a catalyst for lifelong learning, personal growth, and socio-economic advancement. Recognising this, the European Training Foundation (ETF) and UNICEF Europe and Central Asia Regional Office (ECARO) have initiated a collaborative endeavour to delve into and enhance career learning and guidance initiatives for young people.

A joint study aims at capturing young people's opinions and perceptions on access, expectations and needs with regard to career guidance and counselling as well as career education to inform policy responses to significant socio-economic and technological changes and challenges ahead, and ultimately empower young people.

Throughout the year 2023, surveys and focus groups were conducted among over 9,600 young people across 11 countries and the Europe region, covering Albania, Bosnia and Herzegovina, Greece, Kosovo*, Kyrgyzstan, Montenegro, North Macedonia, Romania, Serbia, Ukraine, and Uzbekistan.

Listening to young people ensures that career guidance services effectively meet the evolving needs of young individuals supporting the digital and green transitions, fostering personal growth, lifelong learning, and socio-economic progress.

The study results will feed into the development of youth guarantee schemes in Western Balkans and EU-supported youth activities in Eastern Partnership and Central Asia countries, as well as countries' efforts to revisit career guidance standards and service delivery, (re)training of practitioners and reflection of new dimensions of career guidance and counselling, particularly social inclusion, wellbeing and mental health.

The study not only aims to recommend customised career guidance services but also to shape these services to address the unique challenges faced by youth, including vulnerable groups such as young people not in employment, education or training, those with disabilities, and migrants or displaced adolescents, ensuring a holistic approach to their lifelong learning and career development.

OBJECTIVES OF THE EVENT
