Torino Process monitoring: Presentation of preliminary cross-country results for 2024

11 November 2024, 10:00 – 12:00 CET time, online

INTRODUCTION

The Torino Process and the KIESE¹ data collection are flagship initiatives of the European Training Foundation (ETF), designed to monitor trends in education, skills, and employment in cooperation with partner countries.

In the course of 2023 and 2024, these efforts culminated in the release of Torino Process monitoring reports for each country covering the year 2023. These reports can be accessed here: : <https://www.etf.europa.eu/en/what-we-do/policy-analysis-and-progress-monitoring-torino-process>. Additionally, a cross-country report, offering a comparative perspective on the monitoring results, was released, and is available here: <https://bit.ly/3UcJMWrr>.

The ETF has now completed the KIESE evidence collection for 2024. Since many of the Torino Process monitoring results for countries are based on KIESE data, the ETF is also preparing a 2024 update to the monitoring report for each country, along with a new 2024 edition of the cross-country report.

As part of ongoing discussions with key stakeholders involved in the annual data collection, this meeting will provide Torino Process national coordinators with a preview of cross-country monitoring findings for 2024 ahead of their public release in November 2024. In the coming weeks, each country will also receive its updated Torino Process monitoring report for 2024, for review and validation to ensure the necessary adjustments can be made before final release.

In addition to presenting the preliminary results, the meeting will serve as a forum for discussing the next round of the Torino Process in 2025.

The working language of the meeting is English, with interpretation from/to Arabic and Russian.
