VET developments in candidate countries: closing the Osnabrück cycle – *Country working groups GUIDELINES (AL, ME, MK, RS, TR)*

DATE AND VENUE:

14-15 April 2025, CET - Milan, Italy

During the event, Directors General for VET (DGVTs) and members of the Advisory Council for Vocational Training (ACVTs) from Albania, Montenegro, North Macedonia, Serbia and Türkiye will participate in **TWO COUNTRY WORKING GROUPS**, one each day, linked to the monitoring of vocational education and training (VET) policy developments relevant to their country's National Implementation Plan (NIPs). The working groups will be moderated by ETF national experts in the national language. This document illustrates the objectives of the working groups and the expected input from participants.

Day 1, Monday 14 April from 9.30 to 11.30 – country working groups (I)

- OBJECTIVE: to collect information for the monitoring of 2024 and 2025 (until April) policy developments relevant to countries' NIPs (N.B. not VET developments in general).
- EXPECTED OUTPUT: national experts should have the necessary information to draft for the last country brief¹ of the Osnabrueck cycle, which will cover policy developments of 2024 and 2025².

Your Role: we invite you to come prepared by collecting – before travelling to Milan – the necessary information about policy developments relevant to your country's NIP in 2024 and until April 2025.

If you are not familiar with ETF 'Osnabrueck reporting' please consult the 2023 and 2024 country briefs (see Annex I). Have a look also at the 'thematic priorities' of the Integrated Analytical Framework' (Annex II).

Day 2, Tuesday 15 April from 9.45 to 11.00 – country working groups (II)

- OBJECTIVE: to identify persisting challenges in VET and look forward to the 2026-2030 policy cycle. Based on
 a concise presentation of NIPs progress since 2021, participants will be invited to elaborate reflections on
 the future country priorities, considering the vision outlined in the new Herning Declaration, which DGVTs
 and ACVTs received on Monday 24 March from DGEMPL and which will be presented during the event.
- EXPECTED OUTPUT: identification of three areas of persisting challenges (these will be the focus of the reporting back) and of priority areas for the policy cycle 2026-2030 (considering both the old integrated monitoring framework and the draft Herning Declaration).

YOUR ROLE: we invite you to read the draft Herning Declaration before the event. ACVTs and DGVTs have received it from DGEMPL on March 24. Have a look at the 'EU priorities' of the Integrated Analytical Framework as well.
