## Torino Process 2022-2024: Review of policies for Lifelong Learning in Palestine National validation meeting

## SUMMARY:

Palestine is an active participant in the monitoring activities of the European Training Foundation (ETF) in education, skills, and employment, in particular in the Torino Process - an ETF flagship monitoring and review initiative.

Each year since 2023, the Torino Process foresees two levels of country participation: Level 1 (monitoring of policy and system performance) and Level 2 (policy reviews). Palestine engaged on both Level 1 and Level 2.

This event will present the findings and recommendations of the Level 2 participation of Palestine – the Torino Process review of policies for lifelong learning (LLL), with a specific focus on the technical and vocational education and training (TVET) system and its results in the areas of access, quality, and system management.

The meeting has the following objectives:

1. Present and discuss the main findings of the ETF Torino Process policy review in Palestine
2. Discuss and validate the review recommendations and possible ways for their implementation
