Purpose of the processing

Legal basis (if applicable)

The legal basis for the processing operations of personal data is Regulation No. 1339/2008 establishing the European Training Foundation (Recast), article 2, functions, (f).

Personal data

Personal data concerned are:

Recipients of the personal data

For the purpose detailed above, access to personal data is provided to the following processing entities:

Privacy and security safeguards

The personal data (where provided) is only available to the relevant contactor and ETF team members and will not be shared elsewhere. Any outputs presenting the survey's results will not contain any reference to the responding persons and organisations.

Further information

Data retention

The survey and its results in the survey tool will be destroyed after the conclusion of the survey.

Contractors will keep the raw data for the duration of the project, up to the delivery of the final report, after which they will be eliminated.

The raw data of the surveys will be stored on ETF systems for the duration of maximum 2 years and are accessible only to the ETF team and will not be shared to third parties.

ETF will keep report(s) with aggregated and anonymous data for unlimited period for historical / research purposes.

Right of access, rectification or erasure, restriction, objection
