Introduction

Work-based learning (WBL) is a key priority in VET policies of the European Union, its Member States and in many ETF partner countries. Improving work-based learning in VET is considered a key to address youth unemployment and employability, to better match VET with skills needs of companies and to improve overall relevance and attractiveness of VET. The ETF 3-year regional project on WBL for Eastern Europe and Kazakhstan (2015-2017) and its outcomes confirmed the value and benefits of networking between partner countries in the region and of peer learning with countries of the European Union. It also showed the need for further capacity building for the main stakeholders in view of policy development and implementation of work-based learning in the countries.

Therefore, the ETF will continue to support the policy dialogue with countries in the region through the organisation of an Annual Regional Forum for WBL in VET between 2018 and 2020. This year, the Regional Forum is organised by the ETF in cooperation with the Ministry of Education, Science, Culture and Sport of Georgia. The Annual Forum meeting will be combined with a capacity building offer (Modular Training Course on WBL for policy makers and social partners) developed by ETF to support efforts from countries to improve the quality of WBL to the benefits of both learners and enterprises.

The modular training course on WBL is designed to provide both theoretical knowledge and practical skills on how to develop and implement WBL. The ETF course consists currently of nine complementary modules (see annex 1): Two are e-modules accessible through the ETF's WBL platform (http://etfwbl.eu/home/en/introduction). The others are at present face-to-face modules. Three modules are already in use and the others are under development, in consultation with the Annual Forum. All training modules cover the key areas of WBL that are addressed in the ETF WBL Handbook.

The 2018 Annual Forum on WBL addresses priorities identified by VET stakeholders in the region, based on the findings identified by Partner Countries in making use of the ETF's WBL Readiness Tool and on the outcomes of the Annual Regional Meeting in 2017 in Chisinau, Moldova.

The focus of the 2018 Annual Forum and the Modular Training Course will be on the following:

- Two key functions in WBL: In-company trainers in apprenticeship/dual education & placement coordinators in internship/traineeship;
- Financing mechanisms of WBL.

The main objectives of the 2018 Regional Forum are to:

- To share knowledge and foster policy dialogue between countries in the region;
- To help policy makers and social partners to develop appropriate strategies on WBL in VET;
- To strengthen technical capabilities of stakeholders for planning and implementation of WBL.

The course primarily targets policy makers and social partners from the Eastern Partnership region. It addresses both staff working in the field of employment and professionals working in the VET sector, including:

- Decision makers and experts from ministries, agencies and institutions at national and regional levels;
- Representatives of employers and employees organisations involved in VET development;
- Members of Boards of Educational institutions or committees.

The first two days will be devoted to capacity building, the third day is intended to leave space for sharing knowledge and experiences
