FLASH REPORT TRP RUSSIA Regional event 30 September/01 October 2019

Title of the event

Torino Process 2018-2020 Regional event – Key findings from the regional reports and thematic discussion on Sector Skills Councils, as main challenges identified during the TRP.

Main objective/s of the event

- Share with participants the key findings of the Regional Reports from Bashkortostan, Tver, Samara, Tatarstan.
- Discuss about identified recommendations;
- Share knowledge and experience on Sector Skills Councils functioning in Russia and EU.

Background

The TRP in Russia has been played by the following main actors, at Federal and Regional level:

- Mrs Inna Chernoskutova, Federal Ministry of Education, Head of VET Department TRP Coordination;
- Mr Aleksej Levchenko, Federal Ministry of Education, Deputy Head of VET Department TRP Coordination;
- Mrs Ekaterina Esenina, Federal Institute for Education Development (FIRO), drafter of the TRP national report;
- Mrs Olga Oleynikova, national and regional facilitator;
- Mrs Tanzilia Nigmatullina, local coordinator Region of Bashkortostan;

The fifth round of the TRP was launched in Moscow in November 2018 and from January to June 2019 the ETF TRP team for Russia (see names below) has held monthly webinars with all the participants from the regions to support their analytical process. A part the regions mentioned above, other regions (Irkutsk, Belgorod, Tomsk) expressed the interest in the TRP and participated at the webinars, but did not manage to draft the report.

The regional reports have been submitted to ETF in June to be presented at this meeting.

Short introduction/description of the event

The event has taken place in 2 days: on 30/09 and on 01/10, with a number of participants around 50 each day.

Day 1 was opened by the Head of VET department of the Ministry of Education Mrs Inna Chernoskutova. The opening was followed by the presentation of the Torino Process (by Franca Crestani) and the story of the TRP in Russia (by Olga Oleynikova). The methodology for the TRP policy analysis was presented by Mihaylo Milovanovitch, who underlined that the peculiarity of this round is the focus on the main issues of human capital development and the policy response from the VET side. Day 2 was focused on shatring knowledge and experience on the functioning of Sector Skills Councils in Russia and EU. The experts were Miryam De Joong and Ummuhan Bardak (in Moscow for a conference at the Academy of Sciencies).

KEY OUTCOMES / CONCLUSIONS

The key findings of the regional reports have been presented by the related local coordinators. All the regions have asked for more support to the local authorities responsible for VET to improve the VET management system at regional level.

The discussion on Sector Skills Councils was appreciated in particular for having presented the functioning of the system in some EU countries, like UK, NL, GE.
