FLASH REPORT TRP RUSSIA Dissemination event on 11 November 2019

Title of the event

Torino Process 2018-2020 Dissemination event – Key findings and recommendations of National report of the Russian Federation

Main objective/s of the event

- Share with participants the key findings and recommendations of the National Report (no ETF assessment foreseen for Russia);
- Discuss in detail identified recommendations;
- Identify and agree specific actions to address the recommendations.

Background

The TRP in Russia has been played by the following main actors, at Federal and Regional level:

- Mrs Inna Chernoskutova, Federal Ministry of Education, Head of VET Department TRP Coordination;
- Mr Aleksej Levchenko, Federal Ministry of Education, Deputy Head of VET Department TRP Coordination;
- Mrs Ekaterina Esenina, Federal Institute for Education Development (FIRO), drafter of the TRP national report;
- Mrs Olga Oleynikova, national and regional facilitator;
- Mrs Tanzilia Nigmatullina, local coordinator Region of Bashkortostan;
- Mrs Tamara Golubeva, local coordinator Region of Tver;
- Mr Andrey Glazkov and Mrs Enze Xxxx, local coordinators Region of Tatarstan;

The fifth round of the TRP was launched in Moscow in November 2018 and from January to June 2019 the ETF TRP team for Russia (see names below) has held monthly webinars with all the participants from the regions. A part the regions mentioned above, other regions (Irkutsk, Belgorod, Tomsk) expressed the interest in the TRP and participated at the webinars, but did not manage to draft the report.

The regional reports have been submitted to ETF in June and presented in the meeting in Moscow on 30 September. The National report has been drafted taking into consideration the regional outcomes and submitted to ETF in October for comments. The final version of the report will be done after the November event.

The EU Ambassador expressed interest in having a TRP publication with the regional stories.

Short introduction/description of the event

The event has taken place on 11 November in the premises of the EU Delegation in Moscow. It was opened by the EU Ambassador, Mr Markus Ederer; the ETF Director, Mr Cesare Onestini; and by the Deputy head of VET department of the Ministry of Education Mr Aleksej Levchenko. The number of participants was around 50.

The opening was followed by the presentation of the Torino Process (by Franca Crestani) and the story of the TRP in the Regions (by Olga Oleynikova).

Afterwards, there was the presentation of the National report, by Mrs Ekaterina Esenina and the discussion of the challenges and key recommendations, reported below.

KEY OUTCOMES / CONCLUSIONS

The key recommendations of the TRP national report have been expressed in terms of challenges for the future, and summarised by the key words: openness, flexibility, systematicity of VET and LLL:

- Improve PPP to enhance the practice oriented education at VET provision level, with particular focus on improvement of equipment for the practice.
- Develop the conditions for the inclusion of measures taken to ensure matching of qualifications with LM requirements.
- Develop methodology and approach to support the development of the VET system at regional level.
- Provide support to the local authorities responsible for VET to improve the VET management system at regional level.
