



Decision of the ETF Governing Board on the adoption of implementing rules to the Staff Regulations

The Governing Board of the ETF,

Having regard to the Staff Regulations of Officials (Staff Regulations) and the Conditions of Employment of Other Servants (CEOS) of the European Union, laid down by Council Regulation (EEC, EURATOM, ECSC) No 259/68, as last amended¹, and in particular to Article 110 (2) thereof;

Having regard to the Council Regulation (EC) n° 1339/2008 of 16 December 2008 establishing a European Training Foundation (recast)², and in particular Article 21 thereof,

Having regard to the Decisions of the Commission of 16.12.2013 establishing implementing rules for the application of the amended Staff Regulations of Officials and the Conditions of Employment of Other Servants of the European Union,

After consulting the ETF Staff Committee,

Has adopted the following Decision:

Article 1

The general implementing provisions of the Staff Regulations, as adopted by the Commission, and listed in Annex I, shall be applied by analogy in the ETF.

Article 2

The corresponding decisions of the ETF Governing Board also listed in Annex I shall be repealed.

Article 3

This decision shall take effect as of 1 January 2014.
