



## **Governing Board Decision for empowering the ETF Director to request the Commission's agreement to the non-application of Commission rules.**

### **THE GOVERNING BOARD OF THE ETF,**

Having regard to the Staff Regulations of Officials ('Staff Regulations') and the Conditions of Employment of Other Servants of the European Union ('CEOS') laid down by Council Regulation (EEC, Euratom, ECSC) No 259/68<sup>1</sup>, and in particular Article 110(2) thereof,

Having regard to the Council Regulation (EC) n° 1339/2008 of 16 December 2008 establishing a European Training Foundation (recast)<sup>2</sup>,

Having regard to Communication C(2014) 6543 final of 26 September 2014 from Vice-President Šefčovič to the Commission on the guidelines on the implementation of Article 110(2) of the Staff Regulations with regard to the implementing rules applicable in the agencies, and in particular Point 2.B thereof,

Having regard to the following Commission Decisions:

- C(2016) 3828 and 3855 regarding respectively the implementation of the learning and development strategy of the Commission and training on the own initiative of the member of staff,
- C(2016) 3214 regarding the function of advisor and repealing previous Commission decision,
- C(2016) 3288 regarding middle management staff and repealing previous Commission decision

Having regard to the fact that ETF Governing Board already adopted a decision regarding middle and senior management staff (GB/10/DEC/004),

Having regard to the fact that Agencies differ from the Commission, particularly as regards the nature of their staff and structure,

Having regard to the fact that the Commission's services, with the assistance of the Standing Working Party, will be drafting model decisions in these areas more adapted to the agencies peculiarities,

### **HAS ADOPTED THE FOLLOWING DECISION**

#### ***Article 1***

The ETF Director is empowered to request the Commission's agreement to the non-application of the following Commission decisions:

- C(2016) 3828 and 3855 regarding respectively the implementation of the learning and development strategy of the Commission and training on the own initiative of the member of staff,
- C(2016) 3214 regarding the function of advisor and repealing previous Commission decision,
- C(2016) 3288 regarding middle management staff and repealing previous Commission decision
