GAMM - Global Approach To Migration and Mobility

- Since 2005, the framework of the EU external migration and asylum policy
- defines how the EU conducts its policy dialogues and cooperation with non-EU countries

Priorities of the GAMM

- Better organising legal migration
- Preventing irregular migration, and eradicating THB
- Maximising the development impact of migration and mobility
- Promoting international protection and enhancing the external dimension of asylum

Geographic balance

- The framework and methodology of the GAMM are being applied globally with relevant non-EU countries
- Priority is given to the immediate southern and eastern neighborhood
- The most elaborated bilateral cooperation frameworks under the GAMM are the Mobility Partnerships (MP)

Jordan-EU Mobility Partnership

- On 9th October 2014, **the EU signed a Mobility Partnership with Jordan** together with 14 EU Member States. Lithuania joined in July 2015 and the Netherlands joined by the beginning of 2016 which makes it now 16 participating MS (Sweden, Romania, Portugal, Poland, Hungary, Cyprus, Italy, France, Spain, Greece, Germany, Denmark, Bulgaria, Lithuania, Czech Republic, and Netherlands)

Jordan-EU Mobility Partnership - 2

- 4 areas of cooperation ...
- mobility and legal migration,
- border management
- fight against irregular migration,
- development and international protection..

Jordan-EU Mobility Partnership - 3

- The mobility partnership provides a coherent framework for actions to be implemented together by
- the EU,
- participating Member States
- Jordan , in a comprehensive manner and in line with the EU's Global Approach to Migration and Mobility.

Jordan-EU Mobility Partnership - 4

- In July 2016, an EU-funded € 2.5 M project in support of the Mobility Partnership with Jordan, implemented by the International Centre for Migration Policy Development (ICMPD), was launched..
- two thematic components: a) engagement with Jordanian expatriates abroad and b) addressing trafficking in human beings

Jordan-EU Mobility Partnership - 5

- The European Council on 11 April 2016 approved the Commission's mandate to enter into parallel negotiations with Jordan on visa facilitation and readmission
- Comments expected from JO

Ex : MEDSTAT III - Migration

- 7 million € project implemented between 2010 and 2013
- The project aimed to improve statistical capacity and ensure the institutional strengthening of the national statistics institutes and national statistical system..
- Almost € 1 million was allocated to the activities undertaken by the Migration sector

Ex :Sustaining Quality Education and Promoting Skills Development Opportunities for Young Syrian Refugees in Jordan

- This project was implemented by **UNESCO** and is aimed at achieving two objectives (end 2015)
- *Sustained quality of education for Syrians and Jordanians through upgrading of training for teaching force and related teaching personnel.*
- *Demand-driven educational, informal/non-formal education and skills development opportunities to Syrian and Jordanian youths affected by the Syrian Crisis in Jordan*

Ex : Bilateral Projects

- ***France has agreed to a bilateral project on document forgery.***
- The *Direction centrale de la police aux frontières* of the French Ministry of Interior, carried out some trainings in the fight against document fraud.
- ***ITALY - Support to the Jordanian Law Enforcement in Combating Smuggling of Migrants and Trafficking in Persons.***
- The *overall objective* of this project is to strengthen the capacity of the Government of Jordan to fully implement national strategies and legislative requirements as well as international standards for combating smuggling of persons and trafficking in persons
